










How to get info on what is hidden from the tax admin (our best source of register data)?

Is real estate the new tax haven?

Offshore real-estate...



... is often opaquely or anonymously owned making it hard for authorities, journalists and tenants to discover the real owner...



... is hard to track for tax administrations and other government agencies, as there exists no systematic exchange of information about real estate ownership between governments



... is particularly attractive to money launderer due to its opacity, money launderers, stability in value, and ability to manipulate the price

E24 coordinates 25 int. newsrooms.

Launch: May 3, 2022




Dubai: part of CRS – Property registers not public.

Figure 2: Value of Real Estate in Dubai in 2020 (USD Billion)



Figure 4: Real Estate Held in Dubai in 2020: Top 20 Countries





Figure 9: Real Estate Held in Dubai in 2020: Top 20 Countries (Affluent areas vs. All areas)






What do we know of foreign ownership of real estate in Norway?

Foreign ownership share in 2017:

- 2%
- 10% when zooming in on corporations
- Tax haven ownership increasing








Foreign owned real estate in Oslo 2019, Billion USD


Oslo: Changes btw 2010 and 2019, share of foreign owned


Comparison across countries – Billion USD
